FREQUENTLY ASKED QUESTIONS

What is Uzpruvo® for?



UZPRUVO® is indicated for the treatment of moderate to severe Crohn's disease in adults, moderate to severe plaque psoriasis in adults, moderate to severe paediatric plaque psoriasis and psoriatic arthritis in adults.¹

What is Uzpruvo® Homecare Service?

Convenient, discreet medicine delivery & support

Uzpruvo® homecare simply means that your medicine will be delivered directly to you. This can be to your home address or to another address, if that fits in better with your lifestyle. The advantage of Uzpruvo® homecare is that you won't need to wait for your medicine to be dispensed and there is no need to carry it home with you from the pharmacy.

It's important to remember the homecare service is for the supply of your medicine only. You should still attend all clinic appointments.

How it works

The healthcare professional responsible for your care will send your Uzpruvo® prescription directly to a specialist homecare company. Once registered for Uzpruvo® Homecare, the homecare company will contact you to arrange a convenient time and place to deliver the medicine, as well as training if it's your first time using it.

Delivery usually happens when you have about two weeks of medicine left, ensuring you never run out.

FREQUENTLY ASKED QUESTIONS

How do I register for homecare?

The healthcare professional responsible for your care will discuss Uzpruvo® homecare with you and will check if homecare is the right service for your particular needs.

You will need to have a phone, which can either be a mobile or a landline. This is so the homecare team can contact you about delivery of your medicine. There is a registration form which you will need to fill in and your health professional will help you to do this.

Your consent will be required for sharing your details with the homecare company. This is necessary so they can organise an account for you and start delivering Uzpruvo®.

How long does it take to set up Uzpruvo® homecare?

Once you join the Uzpruvo® Homecare Service, it will take no more than 5 working days between each step.



What if I change my mind about homecare?

If you decide homecare isn't for you, you can cancel anytime - it won't affect your medical care. Just let your healthcare team know. They'll arrange for you to collect Uzpruvo® prescriptions from an alternative pharmacy.

Who will deliver my medicine?

The Uzpruvo® Homecare Service allocated to you will depend on who has prescribed your treatment, but the three key companies who support this service are:

FREQUENTLY ASKED QUESTIONS

What if I need help in administering Uzpruvo®?

Don't worry, training to administer Uzpruvo® is part of the homecare service. So you'll get all the support you need to feel confident using the syringe.

You can choose from the following nursing options:



Virtual



Face-to-face



Telephone

- Convenient, accessible nurse training
- All patients will receive an assessment by the Homecare provider and Nursing pathway agreed based on patient need
- Pathways include virtual, telephone or face-to-face nursing sessions

How will my medicine be delivered?

Uzpruvo®'s Homecare Service delivers your treatment to your home or another address more convenient for you. You choose the day and time, to make sure delivery fits your plans.

What will my first homecare delivery include?

Along with your medication (depending on the indication):

- Uzpruvo® Patient Guide (Crohn's Disease) *or*
- Uzpruvo® Patient Guide (Psoriatic Arthritis) *or*
- Uzpruvo® Patient Guide (Plaque Psoriasis) *and*
- Uzpruvo® Patient Card

FREQUENTLY ASKED QUESTIONS

What if I won't be home for my delivery?

If something unexpected happens, contact your homecare company as soon as possible so they can rearrange delivery. Wherever possible, please give at least 48 hours' notice to help make sure delivery can happen at a time convenient for you.

What if I'm moving house?

Please let your healthcare team and homecare company know if your contact details change, such as address and telephone number.

What if I'm away or on holiday?

If you're staying in the UK, your medicine can be delivered to an alternative address. Just let your clinician and homecare company know at least two weeks before going away.

If you're travelling abroad, you may need extra Uzpruvo® supplies to take with you and a cool bag for storage. Your homecare company can arrange this for you. Please give them at least four weeks' notice so extra supplies can be delivered to your UK address before you travel.

How should I store Uzpruvo®?

Uzpruvo® has a shelf life of 3 years.

Individual pre-filled syringes may be stored at room temperature up to 30 °C for a maximum single period of up to 30 days in the original carton.

Once removed from the refrigerator, record the discard date in the space provided on the outer carton. The discard date must not exceed the original expiry date printed on the carton. Once a syringe has been stored at room temperature (up to 30 °C), it should not be returned to the refrigerator. Discard the syringe if not used within 30 days at room temperature storage or by the original expiry date, whichever is earlier.

Store in a refrigerator (2 °C – 8 °C). Do not freeze.

Keep the pre-filled syringe in the outer carton in order to protect from light.
